Further, should you be selected as the successful offeror, you will be required to certify your socio-economic status for the NAICS identified in the BPA, in accordance with the current associated size standards established by the Small Business Administration (SBA), and that the identified NAICS is available on the applicable GSA schedule, as of the date of your signature on the task order award.

Your quotation shall separately address experience, functional approach, price, and socio-economic support. You are also required to submit an executed Organizational Conflict of Interest Certification for the prime contractor/team leader and any proposed subcontractors and/or team members, utilizing the format set forth in BPA Attachment 5.


